FIRST AID PROCEDURES:  
**EYES:** IF TABLET DUST GETS IN EYES, FLUSH EYES WITH LARGE AMOUNTS OF WATER FOR AT LEAST 15 MINUTES WHILE HOLDING THE EYELIDS OPEN. IF IRRITATION PERSISTS, GET MEDICAL ATTENTION.  
**SKIN:** IF TABLET DUST REMAINS IN PROLONGED CONTACT WITH SKIN, WASH AFFECTED AREA WITH LARGE AMOUNTS OF WATER. GET MEDICAL HELP IF IRRITATION PERSISTS.  
**INHALATION:** IF TABLETS ARE SWALLOWED, DRINK PLENTY OF MILK, EGG WHITES, GELATIN SOLUTION OR WATER. SEE A PHYSICIAN. AVOID ALCOHOL.  
NOTE TO PHYSICIAN: PROBABLE MUCOSAL DAMAGE MAY CONTRAINDICATE THE USE OF GASTRIC LAVAGE. MEASURES AGAINST CIRCULATORY SHOCK, RESPIRATORY DEPRESSION AND CONVULSION MAY BE NEEDED.
