



**SKIN.....WASH AFFECTED AREA WITH LARGE AMOUNTS OF WATER. REMOVE CONTAMINATED CLOTHING AND FOOTWEAR. WASH CLOTHING BEFORE REUSE. FOOTWEAR SHOULD BE DECONTAMINATED BEFORE REUSE. GET MEDICAL HELP IF SYMPTOMS PERSIST.**

**INHALATION.....MOVE VICTIM TO FRESH AIR. IF RESPIRATION STOPS, GIVE MOUTH TO MOUTH RESUSCITATION. GET MEDICAL HELP IF SYMPTOMS PERSIST.**

**INGESTION.....NEVER GIVE ANYTHING BY MOUTH TO AN UNCONSCIOUS PERSON. IF SWALLOWED, DO NOT INDUCE VOMITING. GIVE LARGE QUANTITIES OF WATER. (IF AVAILABLE, GIVE SEVERAL GLASSES OF MILK). IF VOMITING OCCURS SPONTANEOUSLY, KEEP AIRWAY CLEAR. SEEK MEDICAL ATTENTION IMMEDIATELY!!**

**STABILITY.....STABLE**

**CONDITIONS TO AVOID.....AVOID TEMPERATURES ABOVE 200° F**

**PROCEDURES: IF MATERIAL IS SPILLED, SWEEP UP INTO SUITABLE DISPOSAL DRUM AND FLUSH AREA WITH WATER**

**WASTE DISPOSAL METHOD...IF MATERIAL CANNOT BE SALVAGED, THE LPREFERRED METHOD OF DISPOSAL IS IN A SECURE CHEMICAL LANDFILL IN ACCORDANCE WITH LOCAL, STATE, AND FEDERAL ENVIRONMENTAL REGULATIONS.**

**RESPIRATORY PROTECTION..... WEAR NIOSH APPROVED DUST/MIST RESPIRATOR FOR PARTICULATES. LOCAL EXHAUST, VENTILATE AS REQUIRED.**

**EYEWEAR.....IF SPLASH POTENTIAL EXISTS, WEAR CHEMICAL SPLASH GOGGLES OR FACE SHIELD.**

**VENTILATION.....GENERAL MECHANICAL VENTILATION OR LOCAL EXHAUST SHOULD BE SUITABLE TO KEEP VAPOR CONCENTRATION BELOW TLV. VENTILATION EQUIPMENT SHOULD BE EXPLOSION PROOF.**

**CLOTHING/PROTECTIVE GLOVES.....WEAR NEOPRENE OR OTHER CHEMICAL RESISTANT GLOVES AND CLOTHING AS NEEDED TO PREVENT SKIN CONTACT.**
